

REQUIREMENTS FOR RENTING

- 1) Applications must be filled out completely and neatly. Please be very specific with employment and previous landlord's addresses. We must have street numbers and zip codes in order to qualify application for rental.
- 2) Each person who will reside in the unit 18 years of age or older, must complete an application.
- 3) Applicant should be employed at least six (6) months on present job. Name, address, and phone number of immediate supervisor are required for verification of employment and monthly income.
- 4) Monthly income should be three (3) times greater than monthly rent for house or apartment you are applying for. (Combined income if more than one applicant)
- 5) Previous landlords must be contacted. Please supply us with their name and phone number.
- 6) All applications are processed through the Experian for a credit rating. Any judgements, collections, slow pay or any credit problems, can be grounds for denying this application. Any application refused because of a credit rating problem can be verified by applicant.

INFORMATION REQUIRED FOR SUBMITTING AN APPLICATION

- 1) \$25.00 in certified funds processing fee per adult or per married couple.
- 2) A photocopy of a valid drivers license, passport or government issued photo ID for all applicants 18 years and older.
- 3) A photocopy of a social security card, ITIN card or receipt from Social Security for all applicants 18 years and older
- 4) A photocopy of all income verification (i.e., recent pay stub, AFDC, SSI, bank statement if direct deposited, or tax returns). All income which is automatically deposited must be accompanied by 2 months bank statements and 2 paystubs or award letter.
- 5) If self employed you are required to submit 3 months bank statements and the last 2 years tax returns, you which must also include your current profit loss statement.
- 6) Upon approval the deposit and the first months rent will need to be paid within 24 hours with certified funds.
NO CASH OR PERSONAL CHECKS
- 7) Collections and/or evictions for former residency are automatic grounds for denial
- 8) Bankruptcies must be discharged for 2 years.
- 9) If identification shows maiden name, a copy of the marriage certificate must be submitted.
- 10) If you wish to have alimony and/ or child support payments included in qualifying income, it must be court ordered and a copy of the court order must be submitted with your application.
- 11) In order for student grants/loans to be included in qualifying income, you must provide copies of the awarded grant/loan paperwork.
- 12) **Co-Signers** – Not all properties allow Co-Signers. Co-Signers must be homeowners, have no credit blemishes and must meet all other requirements.
